the multiple cars together, Please put a note on the waiver form and **I WILL
ATTEMPT** to place the cars side by side.

Move IN TIMES: Mon. March 22 or Tues. March 23 at 9pm
**Move OUT TIMES: Sat. March 27 at 9pm or Sun. March 28 9am-
11:30am. Other Move In or out Times must be approved by NICK
BROWN at the time of registration. Track Displays will be set up at the
same time.**

**Move IN Rules: All Race cars MUST BE WIPED OFF. All cars
inside and out must be cleaned of any mud, snow, water, etc. You ARE
NOT permitted to use any cleaning chemicals (tire shine, armor all, etc)
on the car once inside the mall. MATS MUST BE UNDER ALL TIRES.
IF ENGINE/TRANNY IS IN THE CAR A TARP MUST BE UNDER
THEM. LITTLE OR NO FUEL IN THE CAR. ALL BATTERIES
MUST BE DISCONNECTED. CARS MUST BE PUSHED INSIDE
THE MALL. Should the above rules be violated you will be asked to
leave the mall property with your race car.**
